These are all tough questions which I believe are very close to being answered. We know that we can't expect our governments to fully expose what they know. One can't count





In 1959, his family watched three shiny objects dance around each other in the clear sky above a park in Syracuse, New York, sparking his lifelong interest in UFO/UAP phenomena. ## JULY HIGHLIGHTS



### REPORTED IN THE ANOMALIST

Possibly the most important development in historical UFO research since 1947 is exciting serious ufologists worldwide. The National UFO Historical Records Center (NUFOHRC), led by Executive Director David Marler (and well familiar to Colorado MUFON!), has joined with the Rio Rancho, New Mexico, School District in "a historic partnership aimed at preserving significant historical resources and fostering educational opportunities within the community." For the next five years, the School System will provide housing for the expanding NUFOHRC collection. And UFO history—not indoctrination into any belief about UFOs—will be a springboard to help educate Rio Rancho students in critical thinking and scientific topics other than UFOs. This will also allow researchers to make appointments to visit and volunteers to digitize UFO history for free, worldwide access.

Other UFOs and Government News: "UFOs and Government" stories caused headlines - and concern. Readers will remember the last time that Australian journalist Ross Coulthart claimed he had information that former President and now-2024 Republican Presidential candidate Donald Trump was in danger for what he knew about UFOs. The horrible events of the July 13th assassination attempt likely had no connection to what Coulthart was asserting. But this attack upon the American political system must remind all of us about how fragile human life is; to send our positive thoughts according to our own beliefs towards those tragically affected, and to reexamine how we act towards others and their rightful freedom of expression. John Greenewald reported that Australian researcher Grant Lavac pried out some bits of information on how the "Five Eyes" are coordinating UFO-related efforts. (The "Five Eyes" are the U.S., Canada, Great Britain, Australia, and New Zealand.) Even within the U.S., the UFO news has generally been dismal, and several groups continue advocating for making the UFO problem a 2024 election discussion. Bloomberg News Opinion contributor and George Mason University economics professor Tyler Cowen contends, "The Real Government Conspiracy Isn't about UFOs." Rather, it's "to avoid the embarrassing absence of any real answers" to what UFOs are—besides being a potential national security threat. One plus was John Greenewald's prying away thru FOIA a "User Guide" for a system that "plays a vital role in documenting and reporting UAP incidents for the U.S. Air Force and U.S. Army." Vicente-Juan Ballester Olmos and Luis Cayetano tried to unravel the relationship of the AAWSAP and AATIP programs in a 74-page paper. It's an impressive effort and a handy reference not only for its sources but for future comparison in how its findings and predictions "On the AAWSAP-AATIP Confusion" are substantiated. Note: Ballester Olmos and Cayetano are highly skeptical about the actual anomalousness of UFOs and their pronouncements upon other controversies in UFO and often-connected matters may be irksome. The All-domain Anomaly Resolution Office (AARO) released two studies on that magnesium-zinc-bismuth hunk of stuff (one of "Art's [Bell] Parts") that was purportedly recovered from a crashed extraterrestrial vehicle in 1947 and which has caused so much furor within the ufological world. It's apparently terrestrial, says AARO, and couldn't have worked as a "terahertz wave guide," which some have claimed would have had anti-gravity potential. This is after analysis at the Oak Ridge National Laboratory (coincidentally where former AARO head Sean Kirkpatrick now works). Experts may challenge the results of the impressive array of tests, as well as certain methodological work and "transparency" claims, but at least one mainstream writer had no qualms. And not only has the National Aeronautics and Space Administration shown little public "transparency" in the year since its glossy report came out, but Micah Hanks at The Debrief sees no indication things will change in the future.

Other News: The annual Mutual UFO Network International Symposium was held this year on July 11-14 th in Irving, Texas. An announcement said it would include "The most important UAP-related presentation MUFON has ever made" and provided some information about the "mystery-tinged" "mystery material" that would be described. As of this writing, nothing has come across this reviewer's "desk" on the matter. The Sol Foundation published "Anomalous Health Threats: Health Security Considerations for UAP," which, like other Sol papers, considers important questions regarding "low-probability, highconsequence scenarios" of anomalous encounters. Increased and welcome attention is coming to the African UFO Experience, particularly from writers associated with the excellent European UAP Check organization. European UFO groups continue analyzing and categorizing their countries' sightings. Chrissy Newton (who's starring in a new paranormal "real world) detective show) covered a Journal of Scientific Exploration study on individuals suggesting UFO witnesses have personality traits that increase the likelihood of sightings - and these findings don't support that old "Fantasy- prone Personality" diagnosis. Kevin Randle interviewed David Rudiak on deciphering the infamous "Ramey Memo" associated with the 1947 Roswell "crash." The use of Artificial Intelligence tools supports David's contention that what General Roger Ramey held in his hand while crouching over the "recovered weather balloon material" for an iconic photograph does indicate there were "victims of the wreck," which would be most difficult to believe were a balloon—mere "weather" or "Project Mogul"—involved. And this would lead us either towards the alternate Nick Redfern suggestion of a secret military test involving living beings that went horribly wrong, or of course, the more dramatic interpretation of a non-human construction having suffered the same fate. This is about as clear an exposition as possible of the state of our likely knowledge of this document and its possibly Earth-shaking implications.

Fun, Miscellaneous, and/or Downright Weird: A series of fun articles appeared as a saucer-shaped motor vehicle made its way towards the MUFON International Symposium. The vehicle was pulled over in Missouri and Oklahoma, with law enforcement agencies in both states covering the traffic stop. Tim Binnall reported that a pink saucer went on sale on an Argentinian Facebook site. Colorado's Red Rocks Amphitheatre is making headlines as a sighting by a dozen employees around 1 a.m. June 5th made USA Today and other sources. And on June 23, another of those "mysterious monoliths" appeared, this time on the Morning Fresh Dairy Farm in Bellvue, CO, northwest of Fort Collins. The 9' tall, 4' wide, and 8" deep structure caused so much human traffic and consequent damage that the owner had to have it removed. Some research produced the site <a href="https://monolithtracker.com/">https://monolithtracker.com/</a> which has information on the over 200 such mysterious structures "that are appearing around the world." And we've been impressed with Fin Handley's https://www.youtube.com/@Fin365 site dedicated to reproducing UFO sightings with computer graphics.





## Field Investigator's corner Case 136820

#### From Form 1:

On June 11, 2024, at 6:30 AM in Grand Junction, CO, the witness observed a reflective white tictac-shaped object hovering to the SW of where he was standing. The object was more than a mile away and remained stationary until it disappeared suddenly. A summary of the interview explains that the witness was in his backyard at 6:30 AM or so, working on his new shed. A flash in the sky caught his eye, and he saw what he thought looked like a tictac-shaped object stationary in the sky. From where he was standing, it looked white. He took out his cell phone and took four shots (sent separately). The object was moving very slowly and then, after five minutes, disappeared. Did not shoot out of sight, just disappeared. He estimates it was about 45 degrees and maybe three miles away. The object was to the SW, over the Colorado Monument. He doesn't think the air traffic patterns for Grand Junction Regional Airport travel in that direction.

#### Field Investigator Notes:

There was no metadata available from the photos submitted. All four of the JPEGs show a clear blue sky . Forensically results were inconclusive, besides showing a definite object. I tried using the magnifier function from my computer to make it large enough to be visible. At 500% magnification, it was still impossible to find in two of the four shots so I worked with the one where it was somewhat visible. One photo shows something that is vaguely cylindrical in shape but the image is very fuzzy (this at 500% magnification). With x8 magnification on Forensically the object looks like a whitish blob with a dark halo, which could be a function of the camera. In one shot there appears to be a central section with 4 apparent attachments forming a square. Again, too small and distant to determine anything definitive.


Sunrise on that day was at 5:30 AM; at 6:30 AM, it was at 9 degrees in the East. Hence, it is quite probable that the object reflected the sunlight.

Additional data: Grand Junction Airport is 2.11 miles to the NNE

The weather station releases balloons at 5:PM every day; the station is next to the airport, close to where the witness resides. The previous day's evening winds shifted from NW to N to NNE to E, so if he had seen a weather balloon, it would have had to have drifted around quite a bit. Unfortunately for this possible disposition, weather balloon flights generally only last ~2 hours as they rise rapidly and then burst; meteorologists track them with binoculars and retrieve their instruments after they parachute back to earth.

I then considered a blimp, but they do not travel at that height and remain stationary for long periods. Could it have been a private hot air balloon? Closeups show the shape to be wrong, and no apparent basket hanging from it.

Given the systematic elimination of all possibilities, I am left with only one disposition: Unknown UAV. I am 90%+ sure this is not an airplane, a helicopter, a drone, or a balloon.


