Mike's presentation cautiously examines the premise that UFOs and 'Aliens' may be our future human descendants using time travel technology to visit and study their own ancestral past. An Incredible True Story of Contact with Beings From Another World and Spiritual Awakening

Lily Nova is a new author whose story began when she was visited by UFOs/UAPs while photographing the night sky. She was born and raised in St. Louis, Missouri. She is a college graduate and was a nutritionist and astrophotographer when her contacts began. Her documented UFO/UAP footage has been featured in mainstream news articles all over the world, including the LAD Bible, The Mirror, and the Travel Channel. She currently helps others as a spiritual guide and leads meditations, teaching others how to connect with their star families. She dedicates her life to sharing the truth about UFOs/UAPs and star families.

This book was not a quick read. It is a little over 300 pages. She shares her personal journey and how she connected with and increased her communications with beings that she understood, over time, were her star family. She used her camera to provide visual proof of her many sightings. She shares how to make your connection and strengthen it over time. Her experiences were so transformational that they completely changed her life path. She stresses that people need to get to know themselves and explains how to clear out the fear and garbage that will keep you from making contact.

Mostly, this book is an instructional guide on connecting with UFOs/UAPs and their occupants. It is important to note, that the connections/communications that she shares are through meditation and the mind's eye,(third eye). She shares her perspective on reality. The book is chock full of QR codes you can scan and use to develop your connection.

The author is very upbeat and encouraging. Suppose you are open to meditation and want instruction on how to communicate with non-human entities without making actual physical contact. In that case, this book is for you. You might find this book informative if you are interested in third-eye training. I found her to not be very grounded. In fact, this book was not at all what I expected. Instead of her experience being physical contact, it came across more like a mind game. I think that meditation is great, but I had difficulty accepting her experiences as real. Because of my background, this book was not for me. However, the author did a good job of sharing her personal experiences. She also provided good instruction for those who want to follow,her path. On a scale of 1-5, I rate this book at 2.00.

- President's Report: Don Jewell was introduced as the newest board member, serving as Webmaster.
- Secretary's Report: The April 13, 2024, meeting minutes were approved. The Community Room is reserved for monthly meetings through June 14, 2025.
- Treasurer's Report: Barry Roth presented the financials. The treasurer's report was approved.

REPORTED IN THE ANOMALIST

"UFOs and Government" stories were relatively sparse during this period. That's largely because most of the time, the two Houses of Congress weren't in session. But there were some guite interesting developments. John Greenewald made a FOIA request to the Office of the Director of National Intelligence (ODNI) for communications that could shed light on the collaboration and research efforts on UAP within the Five Eyes alliance. (The "Five Eyes" are the U.S., Canada, Great Britain, Australia, and New Zealand). The ODNI issued what is known as a "GLOMAR" response, which essentially means that the agency "can neither confirm nor deny the existence" of the requested records. John says this "suggests that there may be significant developments or classified activities related to UAP research and collaboration within the Five Eyes alliance or the ODNI." Douglas Dean Johnson published "a proposed 33-page line-by-line rewrite" of the Senatepassed UAP Disclosure Act, which the Pentagon gave congressional negotiators during end-stage negotiations in November 2023. Most of the recommendations included in this document resulted in the "gutting" of the UAPDA as it was finally included in the 2024 National Defense Authorization Act. Johnson's document may be legit, as he's a careful researcher. Whistleblower David Grusch filed a \$2.5 million lawsuit against Loudoun County, Virginia, Sheriff Mike Chapman and an unidentified Sheriff's Office employee for releasing personal information about him. This relates to the negative article about Grusch's behavior acquired through FOIA by a reporter after Grusch's bombshell Congressional testimony.

Probably the biggest story was Luis Elizondo's new book "Imminent: Inside the Pentagon's Hunt for UFOs." Before the August 20th publishing date, Leslie Kean and Ralph Blumenthal reviewed it for the New York Times. They described a quick history of Elizondo's background, government work in the UFO-related sphere, and what has transpired since Lue "blew the whistle." Much of what they noted won't surprise. Exceptions: the "green-glowing orbs...that invaded his home" and his remark about humanity not being the "alpha species" among intelligent life in the universe. After August 20th reviews have included Lue himself writing to clarify his role and the rationale behind his actions during his career, especially the UFO/UAP portion. UFO-savvy Christopher Sharp pointed to Elizondo's specific meanings for the term "Imminent" in his book's title and discussed the thrust of Elizondo's revelations, including the" point of no return" Lue sees as indeed "imminent." A NewsNation writer promised Elizondo would "name names" of companies involved in reverse engineering crash material in a NewsNation special on the 23rd. (Elizondo did, though he was "careful" about whether the materials were ET/alien or known adversary). An Associated Press mainstream evaluation naturally complained about "way too many government acronyms" but seemed to take the book and Elizondo's conclusions seriously. Jason Colavito's hyperbolic essay didn't consider the book's intended main audience is not as "UFO-literate" as us folks, and stuff we'd just nod our heads at would be new to them. I thought the NewsNation interview with Elizondo and the following analysis was decently good. It seemed a bit too "staged" in appearance, and needed a Humanities/Social Science commentator to contrast against physicists Avi Loeb and our favorite SETI astronomer Seth Shostak.

Conferences: The Society for UAP Studies held its SUAPS Summer Conference 2024 online on August 16-18. "Varieties and Trajectories of Contemporary UAP Studies" promised "to provide an excellent, detailed, look at what academics from a range of disciplines are thinking about, and discussing in relation to UAP studies," per Keith Basterfield, and afterward Baptiste Friscourt covered the first day's doings on his Sentinel News site. Keith also reported on the several UFO/UAP-related sessions held at the 2024 American Institute of Aeronautics and Astronautics conference.

Other News: There were hopeful signs the mainstream was taking UFOs/UAP more seriously. Discover Magazine, Science News, and The Hill ran thoughtful, even if at times skeptical articles; another academic paper followed up on the authors' previous study of academic attitudes towards UAP; the "Major Cities Chiefs Association" published a "Police Executives UAP Reference Guide"; and Avi Loeb's TED Talk got a standing ovation, from a venue that historically has discouraged "out there" speculations. Loeb also blogged about "Surviving as a Scientist Among Believers and Skeptics regarding UFOs," justifying the "tightrope" he was walking , giving him some credibility with both such groups. And a 44-year mainstream newsman admitted that the Roswell story had "shadowed" his entire career. (It turned out his parents were friends of Roswell Army Air Field base Public Information Officer Walter Haut.) European UFO groups continued analyzing, categorizing, and reporting upon their countries' sightings. Example: GEIPAN, the French agency responsible for UFO investigations, has released the conclusions of a survey of UAP reports from commercial airline pilots since the fall of 2022. And the Brazilian National Archives released a batch of UAP documents covering encounters between commercial pilots and UFOs last year. A Chrissy Newton podcast covered how counterintelligence engaged with the UAP phenomenon, while Ross Coulthart did an eye (and ear!) opening episode on "What Did John F. Kennedy Know—And Not Know—about UFOs." Anthony Bragalia had a stunning new post: "il Photographed the Aliens at Roswell' Military Cameraman's Taped Confession Revealed." Kevin Randle tried to beat down attempts to revive the 1953 Kingman crash reality; while Micah Hanks had a podcast about the unspeakably horrific WWII Japanese Unit 731 and its possible connection with a "non-alien" Roswell crash. And filmmaker Mark Christopher Lee tried to explain both the 1980 Rendlesham Forest, England and 1990 Calvine, Scotland incidents.

ET Life: My colleagues covered numerous noteworthy topics on this matter including evidence for life on Venus and Mars; odds for and against ET life in general and when we'd first find it if it existed; and another explanation for the famous "WOW!" signal on August 15, 1977. It "may have been caused by a unique astrophysical event: the sudden brightening of a cold hydrogen cloud due to stimulated emission from a transient strong radiation source, such as a magnetar flare or a soft gamma repeater (SGR)." So there! I guess...

Fun, Miscellaneous, and/or Downright Weird: Mummies: Daily Mail's Matthew Phelan reported the US Congress was going to investigate those Jaime Maussan mummies, per Congressman Tim Burchett's promise to Maussan, while skeptical British "ufologist" eviscerated both the mummies and Erich von Daniken's "alien astronauts" claims. The Denver Post's Elizabeth Hernandez wrote "The Business of Bigfoot: Sasquatch Tourism Brings Cryptid-Curious to Colorado." See https://www.denverpost.com/2024/06/29/bigfoot-tourism-colorado/_And Jennifer Sandlin visited the "World's Largest Bigfoot Museum" and tells us we can "See Bigfoot's 'Buttocks Imprint' in Blue Ridge, Georgia" (https://boingboing.net/2024/08/15/see-bigfoots-buttocks-imprint-in-blue- ridge-georgia.html). Okay... And there're more Bigfoot articles after Sandlin's conclusion, too!





Field Investigator's corner Case 137123

This case made national news

From Form 1:

On June 5, 2024 at approximately 1:00 AM, the witness and a group of coworkers witnessed a large, disc-shaped UFO hovering north of Red Rocks Park and Amphitheatre during a load-out for a concert. The sighting occurred when one of the workers pointed out what appeared to be a spaceship, leading the group of about twelve people to all confirm they were seeing the same thing. The UFO, described as a metallic craft several hundred yards long with three levels of windows, was completely silent. As the group focused on it, the craft tilted and began to move eastward, gradually fading away until it vanished. The witness emphasizes that this was not a plane, satellite, or drone, and insists that the entire group saw the same phenomenon.

Field Investigator Notes:

FI confirmed "All Time Low" played at Red Rocks hours before the time of the sighting. There are differences noted by the reporting witness as to what other individuals saw when the object was present. Conversation after the sighting included several stating they were able to see movement or possibly entities through the windows. FI asserts this discrepancy is likely due to the differences in visual acuity among the witnesses.

The double stars Vega and Deneb were visible in the northern sky at the time of the sighting. However, the description provided by the witness is much larger than a star and it moved out of their view. Fl emailed National Weather Service in Grand Junction regarding weather balloon launches, and learned the scheduling and behavior of balloons rule out the possibility of a mis-identified balloon. There were no fireballs or meteor showers of note at the time. The size of the object, brightness and time it was observed does not correspond to Starlink satellites passing over the area around that time. The witnesses didn't report any noise and the object was too large for a drone.

It does not fit the description of the often-observed TR3B triangular shape or common military craft as the object hovered and tipped forward as it moved off. Flight Radar24 had no flights in the northern sky near the time of the sighting. MUFON Case133837 occurred on 6.25.23 in New Mexico. Witness reported a flying skyscraper lying on its side with 2 parallel rows of bright lights approx.100 yds by 300 yds. Witness suffered debilitating physical effects after the object flew low, directly over him. Fl emailed the New Mexico Fl who investigated the case to ask if there were any new developments in the 2023 case, but he had no new information and no additional ties between the cases were found.

I-70 is approximately 2 miles north of the witnesses location. FI reviewed the camera locations along I-70 and the camera angles appear to be too low and pointed in directions. No references to the object were posted on the local Next Door website or the Facebook pages of the Towns of Morrison or Golden or the Jefferson County Sheriff's website. The Good Year Blimp wasn't scheduled to fly through Colorado at the time. If the object sighted was a prop in a movie production, the state of Colorado doesn't require permits to film a movie and FI was unable to track down any details to support the idea. FI used the Jefferson County non-emergency phone number on August 2, to ask if other UAP reports were received around the same time. As of August 6, there has been no response from Jeffco. FI left a phone message for Keith, 720 633-8600, in Tower Control at Rocky Mountain Metropolitan Airport on August 2. As of August 6, there has been no response. The witness has been unable to contact any of his original crew mates for additional interviews.

The witness reported he could see the curvature of the craft due to the glow from the windows, indicating the object appeared to be some type of structured aerial vehicle. As no other explanation can be found, FI is 90%+ confident that it was not a known terrestrial object or astronomical object. The disposition of this case is Unknown UAV.


