Colorado's Hottest UFO/UAP Hot Spot

An investigative opportunity on par with Skinwalker Ranch!

Colorado has more that one UFO hot spot. Recent episodes of "Beyond Skinwalker Ranch" focused on the Thomas Miller Ranch, a few miles east of Trinidad, and on an unnamed ranch east of the Denver area near Elbert. Both of these sites have cattle mutilations, strange radio and other electromagnetic anomalies, and multiple visible sightings of UAP (Unidentified Anomalous Phenomenon) objects covering many years. These events have characteristics that overlap with those at the famous Skinwalker Ranch in Utah.

The San Luis Valley is at the top of the list

But there's one area in Colorado that is extremely ripe for further in-depth investigations, as there's a ton of high strangeness in years of accumulating stories and events. Conveniently located near the center of all of this valley's events is the UFO Watchtower, near Hooper, Colorado, but there's more to the story than just the Watchtower.

Mount Blanca

South-east of the UFO Watchtower a few miles, and highly visible from the tower, stands Mount Blanca.

There are many stories of military and UFO aircraft landing on or even disappearing into Mount Blanca over the years. The earliest mention I could find was of a great-great-grandmother who reported seeing a UFO descend into the top of the mountain back in the late 1800s, although most reports are of more recent incidents. Pretty much every year someone reports lights, jets, or other UFO objects "entering" this mountain.

Sand Dunes

Located just east of the UFO Watchtower, and also highly visible from the tower, are the massive piles of sand in the Great Sand Dunes National Park. There have been many reports of objects darting around, on, or near these dunes, but let's just take a look at the strangeness of the dunes themselves.

The amount of sand in these dunes is staggering; about 6.5 billion cubic meters, or 1.5 cubic miles in volume. Imagine a giant tunnel-boring machine that could carve out a tunnel about 42 meters (140 feet) in diameter. If such a machine could turn all the rock it encountered into sand, and were to deposit that sand into one big pile the size of the Sand Dunes, then that huge tunnel could span the entire continental United States from coast to coast. That's a lot of sand!

Take a look at how nearly perfectly circular the Sand Dunes pile of sand is, or was at one time, before about a third of it perhaps eroded away along the southwest edges...

To be fair, geologists have come up with a complex scientific explanation for the how these dunes probably formed over the past 12,000 years since the last ice age, but the explanations are somewhat forced, and a lot of questions do remain. For example, is it realistic for over 50,000 cubic feet of sand to accumulate each and every day, on the average, for the past 12,000 years in order to form this big of a pile?

Cattle Mutilations

Starting in 1992, researcher Christopher O'Brien has investigated over one thousand paranormal events reported in the San Luis Valley, working with law enforcement and other agencies to attempt to unravel the mysteries. A lot, but not all, of his research has centered on the many still unexplained cattle mutilations. His books are very informative and very well researched. Snippy The Horse

One of the more well known animal mutilations happened in September of 1967, when a horse named Lady (more commonly referred to as "Snippy") turned up dead under very mysterious circumstances. This happened a few miles south of the UFO Watchtower on the Harry King Ranch. There was no blood on the ground, or in the horse, and all tissue, including brain matter, had been removed from the bleached white, bare skeletal remains from the shoulders up. The rest of the body was apparently untouched. The skeleton of this famous horse is on display today at the UFO Watchtower, and it can be seen in documentary episodes such as Ancient Aliens.

UFO Watchtower

Just north of Hooper, Colorado, along highway 17, and 274 miles due south-east from SkinWalker Ranch, is the UFO Watchtower (http://www.ufowatchtower.com/) The owner, Judy Messoline, is always ready to share the latest sightings reported by campers and visitors to the site. She's also been featured in a bunch of the UFO documentary and UFO investigative news shows as well.

Over 300 sightings reports in one place

On the counter top in Judy's education center/gift shop is a thick 3-ring binder full of hundreds of hand-written sighting reports, left by visitors over the years. These sightings are mostly from the Watchtower, or from nearby around the Valley. In the summer of 2023 these documents were scanned and published in book form, now available on Amazon and at the Watchtower.

More research is needed!

Strange sounds, electromagnetic effects, and other high-strangeness phenomenon are often reported from around the San Luis valley, but a lot of these reports are overlooked simply because the more obvious UFO sightings get more attention. I strongly suspect research at the level of that provided at SkinWalker Ranch would reveal a multitude of important, correlating data for researchers.

Many of the sightings presented in the book UFO Sightings from the UFO Watchtower, both verbal and in some scanned photos, show tiny white orbs high in the blue skies above the valley. In appearance and behavior, these resemble the white dots in the sky above SkinWalker Ranch. This is just one of the compelling reasons why more research is needed.

What you can do

If you're in the area, be sure to stop by the UFO Watchtower to ask Judy Messoline about the latest unexplained events in the area. It's pretty much a guarantee she'll always have something new to report! If you wish to research the history of the UFO/UAP events around the valley, be sure to check out Christopher O'Brien's books, and for a fascinating collection of over 300 raw, mostly uninvestigated sightings reports, be sure to read UFO Sightings from the UFO Watchtower.

BOOK REVIEW

UFOs: A Scientist Explains What We Know (And Don't Know)

Robert Powell's book is a fascinating and well-researched look at the mysteries surrounding UFOs, or UAPs (unidentified aerial phenomena). The author takes readers on a journey through the history, science, and recent developments in the study of UFOs, offering a thoughtful and balanced perspective.

Powell, a respected researcher with years of experience, begins by exploring some of the most famous UFO stories, including the 1947 Roswell incident and the 1961 Betty and Barney Hill abduction. 

REPORTED IN THE ANOMALIS'

If our last news cycle with its two Congressional hearings and an AARO Annual Report was "truly historic" for government engagement with the UFO/UAP question, the "Drone Dilemma" eclipses all other aerial anomaly news in this cycle. Last time, we covered the early part of the current sensation with November 20th overflights of three NATO military bases in England. But things really "took off" very quickly after that, and continue developing concerning sidebars. While the heavily populated U.S. northeast, particularly New Jersey and New York, get most attention, important military bases and private infrastructure elsewhere in this country and Europe seem targets. This flap completely overshadows last year's January 28-February 12, 2023, "Balloongate" events in length of time, geographic extent, and public outcry. Like "Balloongate" and contrasting with the general furor ignited by the classic December 16, 2017, New York Times and Politico articles about a secret Pentagon UFO study program and the release (then) of two older government-taken UFO videos of previous UFO encounters, this "unidentified" sensation springs from current sightings, and amateur videos filled social media and mainstream online news sources. Like previous UFO "flaps," most of the footage and general excitement was assuredly due to misidentifications, which federal officials were clear to emphasize. Not to mention earthbound idiots using lasers to "illuminate" the drones and actually striking legally flown airplanes and affecting their crews. But just as certainly—and only ultimately acknowledged by said agencies—a disturbing proportion were/are clearly drones. And these "buzzers" come in a variety of sizes and apparent capabilities, and when they invade the airspace over military bases and sensitive, even nuclear, governmental and non-governmental installations, they pose the potential of serious safety and security risks to uncountable thousands of people in heavily populated areas. Their presence constitutes, at the very least, a surveillance potential damaging to the interests of the United States and its allies, not to mention legal questions about incapacitating them. And the brazenness and coordination displayed by some drones, particularly those over English NATO bases, backed up by their apparent immunity to tracking and "downing" by our protective resources or to mitigate the incursions, bespeak a frightening disregard for what is commonly called the most powerful nation on Earth.

Almost as scary to many, the official federal response is characterized by a lack of candor, which only invites the formation of "conspiracy theory"-type thinking. Example: one Congressman, on the authority of unnamed people, claimed the Iranians were launching drones from off our Eastern seaboard. He had to back off a bit after an expert in maritime operations showed a "live" satellite picture of the two Iranian "mother ships" (actually refurbished commercial tankers) still undergoing trials off the Iranian coast. But even that "fizzled" claim illustrated that "bad actors" with money and their own interests at heart were developing "asymmetric" techniques against which organized governments had insufficient defenses. And The War Zone, which has for quite a long time (as the writers note) sounded the alarm against drones, continues decrying the insufficient U.S. and other organized nation preparation for this kind of espionage/terrorist/warfare. Even the incredible resourcefulness of the Ukrainian people against the Russian behemoth, with Ukrainian counter-drone and drone-using innovations, has apparently not prompted much Pentagon interest.

"Hybrid warfare" through proxies (criminal or lesser states) funded and/or equipped by unfriendly powers—most commonly named being the People's Republic of China—became more than a bad dream, but a real possibility. The PRC is rumored to have bought up land around some sensitive U.S. installations, which could be used to launch spying operations. There's even suggestions legally purchased drones from the Chinese DJI company could communicate useful intelligence through "back-door" digital means to that nation. Russia, angered by apparent U.S.-British moves toward beefing up nuclear strike capabilities in Britannia, is also regarded as reacting with its own hardware or through others. One English expert even suggested the Kremlin was somehow "hoodwinking" local hobby or commercial groups to spy for it. Next: a single Senator scuttled a bipartisan Senate move toward equipping the federal government with a better response to the problem. We've learned that around 900,000 drones are legally in use in the U.S. and another 300,000 in Canada. The cheapness of drones in general has made them useful in many legal ways, but Canada's CADORs (Civil Aviation Daily Occurrence Reporting System), some of whose aerial anomalies The UFO Talker podcast covers every week, is showing an alarming number of close sightings by commercial aircraft. A now-mandatory reporting system for nuclear power plant sites is also indicating a skyrocketing rise in drone incursions in the U.S.

What can be said about the "truly anomalous" drones? There may very well be more than one explanation for the reports more resistant to "write-offs" such as birds, airplanes, poorly estimated size/distance cases, etc. The really concerning drones seem to be generally larger than hobby types. Some seemingly demonstrate one or more of the classic UAP "Observables." Former government insider Chris Mellon described a drone "mothership" with apparent capabilities beyond what might be regarded as "cutting edge." Some seem to possess state-of-the-art preset, autonomous movements and don't need to communicate with their senders in ways detectable through traditional means. And experts warn that the increasing implementation of artificial intelligence in drones will create a "whole new ball game."

Other news includes The UFO Talker host Michael Ryan uncovering documents alluding to a formal Canadian governmental military unit that, in the 1960s at least, was investigating UFOs. Michael has also unearthed more information about a 2015 multinational, simulated recovery of a downed Cessna aircraft in the Lake Winnipeg area, many of whose documented features sound much more than just a fairly standard practice crash-retrieval exercise. In early December, AARO gave a closed-door secure room briefing to members of the House Oversight Committee. This is a follow-up to the November 13th meeting we covered last time, but we at least heard nothing about what was discussed or attendees' reactions. And in early December, a United Airlines and a medevac airplane reported three or four "red circular lights zipping around" at different altitudes over Oregon.





Field Investigator's corner Case 139164

The witness, while on a hunting trip, observed an unusual aerial object after returning to camp from scouting the terrain. The sky was transitioning from dusk, with faint light in the west and darkness in the east. Facing southeast, the witness noticed an object traveling steadily from north to south at a very high altitude. Initially suspecting it might be a satellite due to its height and complete silence, the witness noted that, in the remote area, sounds typically carried well, and he could hear jets passing overhead at similar altitudes. Unlike jets, this object emitted no sound, and its lights remained steady.

Intrigued, the witness used binoculars for a closer look. He observed three lights forming a triangular pattern with a steady yellow light in the center. The object maintained its trajectory until it disappeared into the distance. The witness recorded the time of the sighting and created a quick sketch for reference.

Three key observations stand out regarding this incident:

Witness's Expertise: The witness is a highly trained observer with a professional background in aviation inspection, making him well-versed in navigation lights and FAA regulations. This expertise lends credibility to his account and his ability to distinguish between conventional aircraft and anomalous objects.

Diligent Documentation: The witness demonstrated methodical observation by carefully noting the time of the sighting and creating a quick sketch. This indicates a deliberate effort to document the event accurately, reinforcing the reliability of his account.

Consistency with Prior Sighting: The object described by the witness matches an earlier report from Moffat County this year. Despite not capturing a photograph, the details of his description, including the triangular pattern of lights and silent operation, are identical to the previous sighting, suggesting a pattern or connection between the two events.


Upon reviewing the available data:

Satellites and Aircraft: The observed object's trajectory did not align with the direction of satellites overhead or transponding flights, ruling out these conventional explanations.

Witness Reliability: The witness's expertise in aviation inspection and methodical documentation underscores the credibility of the account.

Correlation with Moffat County Sighting: The object's description closely matches a previous sighting in Moffat County, identified as a UAV. The consistent details, including its triangular light pattern, silent operation, and high altitude, strongly support this connection.

Given the witness's reliability, the lack of alternative explanations, and its resemblance to a confirmed UAV sighting, categorizing the disposition as Unknown: UAV is appropriate.
